

If you or your child were bitten in Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often [personal injury wrongful death lawyer](#) reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

This evidence does not last. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
