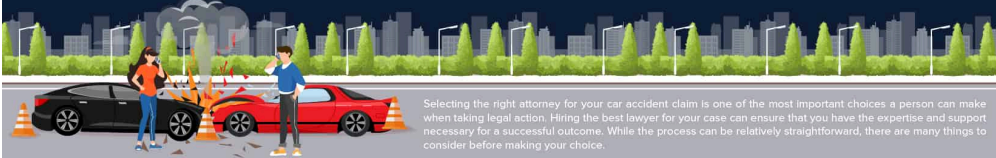


HOW TO PICK THE RIGHT LAWYER AFTER A CAR ACCIDENT
