Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. [Atlanta personal injury attorney](#) Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
