

If a dog bit you in the Atlanta area, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. The question is normally whether the owner had **truck accident lawyer** reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route **affordable car wreck lawyer** is hard to prove. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
