

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

A site has an owner, the general contractor, the electrical sub, sometimes a utility, occasionally an equipment maker, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a **car wreck attorney** third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money [truck accident lawyer](#) is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
